We explain your rights to you and help you claim these rights if necessary. We collaborate closely with other counselling centres and provide information about trade unions in Germany.

The counselling provided by Fair Integration is aimed at refugees and other migrants who are not from the EU.

If you require legal advice or representation by a lawyer, we can help you find an appropriate office.

We advise you on issues relating to your rights and obligations as an employee and support you if you are facing problems in your job.

- **Questions about your working conditions?**
- **Questions about your payment?**
- **Uncertain whether your rights as an employee are being respected?**

Advice is free-of-charge and confidential.

- **if you are employed or have a training contract or are doing an internship, or**
- **if you want to start employment and if you want to find out beforehand about your rights and obligations as an employee in Germany.**

Fair Integration has counselling centres in all 16 federal states and is implemented by various providers within the Network “Integration through Qualification (IQ)”.
